THE AMERICAN RESCUE PLAN ACT

Made available \$179.7 million to Arizona to invest in home and community-based services to expand access to care for seniors and people with disabilities and raise wages for workers. ¹



Vaccinations



85% of all Arizona seniors are vaccinated, better protecting them from COVID-19.²



Protection for Residents

Made available \$6.2 million to help protect nursing home residents from COVID-19.



Senior & Caregiver Services

Provided a \$14.7 million investment to support older adults and family caregivers in Arizona.⁴



Food Security

Secured an \$16.8 million investment to provide nutritious meals to seniors in Arizona.⁵



Combating Elder Abuse

Allocated landmark funding to better protect the one in ten older Americans who experience a form of elder abuse in a given year.⁶



Help for Grandfamilies

Established a National Technical Assistance Center to help the more than 62,000 grandfamilies raising grandchildren in Arizona.⁷

THE INFRASTRUCTURE INVESTMENT AND JOBS ACT



High-speed Internet

Will help the more than 230,000 Arizona households with at least one senior that report no internet access to obtain high-speed internet.⁸



Mass Transit

Will improve transit and make it more accessible for the more than 939,000 individuals in Arizona with disabilities through an investment of at least \$903 million.¹⁰
