

# HOW DEMOCRATS' AGENDA BENEFITS OLDER ADULTS AND PEOPLE WITH DISABILITIES IN ARIZONA

## THE AMERICAN RESCUE PLAN ACT

Made available \$179.7 million to Arizona to invest in home and community-based services to expand access to care for seniors and people with disabilities and raise wages for workers.<sup>1</sup>



### Vaccinations

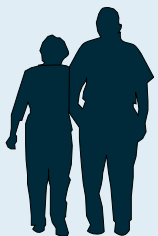


85% of all Arizona seniors are vaccinated, better protecting them from COVID-19.<sup>2</sup>



### Protection for Residents

Made available \$6.2 million to help protect nursing home<sup>3</sup> residents from COVID-19.



### Senior & Caregiver Services

Provided a \$14.7 million investment to support older adults and family caregivers in Arizona.<sup>4</sup>



### Food Security

Secured an \$16.8 million investment to provide nutritious meals to seniors in Arizona.<sup>5</sup>



### Combating Elder Abuse

Allocated landmark funding to better protect the one in ten older Americans who experience a form of elder abuse in a given year.<sup>6</sup>



### Help for Grandfamilies

Established a National Technical Assistance Center to help the more than 62,000 grandfamilies raising grandchildren in Arizona.<sup>7</sup>

## THE INFRASTRUCTURE INVESTMENT AND JOBS ACT

### High-speed Internet



Will help the more than 230,000 Arizona households with at least one senior that report no internet access to obtain high-speed internet.<sup>8</sup>



### Mass Transit

Will improve transit and make it more accessible for the more than 939,000 individuals in Arizona<sup>9</sup> with disabilities through an investment of at least \$903 million.<sup>10</sup>
