### THE AMERICAN RESCUE PLAN ACT

Made available \$139.5 million to Indiana to invest in home and community-based services to expand access to care for seniors and people with disabilities and raise wages for workers.<sup>1</sup>





#### Vaccinations

Over 86% of all Indiana seniors are vaccinated, better protecting them from COVID-19.<sup>2</sup>



#### **Protection for Residents**

Made available \$15 million to help protect nursing home residents from COVID-19.<sup>3</sup>



### Senior & Caregiver Services

Provided a \$12.4 million investment to support older adults and family caregivers in Indiana.<sup>4</sup>



### **Food Security**

Secured a \$14.5 million investment to provide nutritious meals to seniors in Indiana.
