THE AMERICAN RESCUE PLAN ACT

Made available \$43.3 million to New Hampshire to invest in home and community-based services to expand access to care for seniors and people with disabilities and raise wages for workers. ¹



Vaccinations



Over 93% of all New Hampshire seniors are vaccinated, better protecting them from COVID-19.²



Protection for Residents

Made available \$2.6 million to help protect nursing home residents from COVID-19.³



Senior & Caregiver Services

Provided a \$3.2 million investment to support older adults and family caregivers in New Hampshire.⁴



Food Security

Secured a \$3.7 million investment to provide nutritious meals to seniors in New Hampshire.⁵



Combating Elder Abuse

Allocated landmark funding to better protect the one in ten older Americans who experience a form of elder abuse in a given year.



Help for Grandfamilies

Established a National Technical Assistance Center to help the more than 6,000 grandfamilies raising grandchildren in New Hampshire.⁷

THE INFRASTRUCTURE INVESTMENT AND JOBS ACT



High-speed Internet

Will help the more than 34,000 New Hampshire households with at least one senior that report no internet access to obtain high-speed internet.⁸



Mass Transit

Will improve transit and make it more accessible for the more than 172,000 individuals with disabilities in New Hampshire through an investment of at least 126 million.¹⁰
