THE AMERICAN RESCUE PLAN ACT

Made available \$434.4 million to Ohio to invest in home and community-based services to expand access to care for seniors and people with disabilities and raise wages for workers.¹



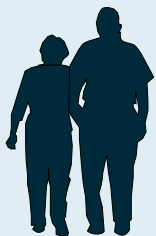
Vaccinations

Over 87% of all Ohio seniors are vaccinated, better protecting them from COVID-19.²



Protection for Residents

Made available \$27.3 million to help protect nursing home residents from COVID-19.³



Senior & Caregiver Services

Provided a \$23.5 million investment to support older adults and family caregivers in Ohio.⁴



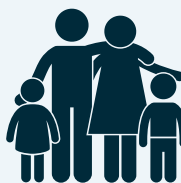
Food Security

Secured a \$27.2 million investment to provide nutritious meals to seniors in Ohio.⁵



Combating Elder Abuse

Allocated landmark funding to better protect the one in ten older Americans who experience a form of elder abuse in a given year.⁶



Help for Grandfamilies

Established a National Technical Assistance Center to help the more than 86,000 grandfamilies raising grandchildren in Ohio.⁷

THE INFRASTRUCTURE INVESTMENT AND JOBS ACT



High-speed Internet

Will help the more than 452,000 Ohio households with at least one senior that report no internet access to obtain high-speed internet.⁸



Mass Transit

Will improve transit and make it more accessible for the more than 1.6 million individuals with disabilities in Ohio through an investment of at least \$1.4 billion.¹⁰
