THE AMERICAN RESCUE PLAN ACT

Made available \$124 million to Oregon to invest in home and community-based services to expand access to care for seniors and people with disabilities and raise wages for workers.¹



Vaccinations



90% of all Oregon seniors are vaccinated, better protecting them from COVID-19.²



Protection for Residents

Made available \$4.8 million to help protect nursing home residents from COVID-19.³



Senior & Caregiver Services

Provided a \$8.6 million investment to support older adults and family caregivers in Oregon.⁴



Food Security

Secured a \$9.9 million investment to provide nutritious meals to seniors in Oregon.⁵



Combating Elder Abuse

Allocated landmark funding to better protect the one in ten older Americans who experience a form of elder abuse in a given year.⁶



Help for Grandfamilies

Established a National Technical Assistance Center to help the more than 17,000 grandfamilies raising grandchildren in Oregon.⁷

THE INFRASTRUCTURE INVESTMENT AND JOBS ACT



High-speed Internet

Will help the more than 116,000 Oregon households with at least one senior that report no internet access to obtain high-speed internet.⁸



Mass Transit

Will improve transit and make it more accessible for the more than 616,000 individuals with disabilities in Oregon through an investment of at least \$796 million.¹⁰
