The Better Care Better Jobs Act Invests in Cost-Effective Services

Cost of Home Care Per Person/Per Year	Cost of Congregate Care Per Person/Per Year
\$26,000 ⁴	\$90,000 ⁵

The Better Care Better Jobs Act would provide over 42,000 more seniors and people with disabilities with needed services in Montana⁷

THE BETTER CARE BETTER JOBS ACT WOULD CREATE

Over 6,800 new home care jobs in Montana and raise wages for care workers—the median wage is roughly \$12 per hour⁸
