# A BILL

To amend the Older Americans Act of 1965 to establish the Office of Older LGBT Policy and a rural outreach grant program carried out by such Office, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*

2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Elder Pride Act of

5   2018”.

6       **SEC. 2. DEFINITIONS.**

7       Section 102 of the Older Americans Act of 1965 (42

8   U.S.C. 3002) is amended—

1                         (1) by redesignating paragraphs (34) through  
2                         (40) and paragraphs (41) through (54) as para-  
3                         graphs (35) through (41) and paragraphs (43)  
4                         through (56), respectively;

5                         (2) by inserting after paragraph (33) the fol-  
6                         lowing:

7                         “(34) The term ‘LGBT’ means lesbian, gay, bi-  
8                         sexual, or transgender.”; and

9                         (3) by inserting after paragraph (41), as so re-  
10                         designated, the following:

11                         “(42) The term ‘older LGBT individual’ means  
12                         an older individual that identifies as LGBT.”.

13 **SEC. 3. OFFICE OF OLDER LGBT POLICY.**

14                         (a) ESTABLISHMENT.—

15                         (1) IN GENERAL.—Section 201 of the Older  
16                         Americans Act of 1965 (42 U.S.C. 3011) is amend-  
17                         ed by adding at the end the following:

18                         “(g)(1) There is established in the Administration an  
19                         Office of Older LGBT Policy (referred to in this sub-  
20                         section as the ‘Office’).

21                         “(2) The Office shall be headed by a Director of the  
22                         Office of Older LGBT Policy (referred to in this sub-  
23                         section as the ‘Director’) who shall be appointed by the  
24                         Secretary.

25                         “(3) The Director shall—

1           “(A) coordinate activities within the Department  
2       of Health and Human Services, and between  
3       other Federal departments and agencies, to assure a  
4       continuum of improved services for older LGBT in-  
5       dividuals;

6           “(B) serve as the effective and visible advocate  
7       on behalf of older LGBT individuals—

8           “(i) within the Department of Health and  
9       Human Services and with other departments  
10      and agencies of the Federal Government re-  
11      garding all Federal policies affecting such indi-  
12      viduals; and

13           “(ii) in the States to promote the enhanced  
14      delivery of services and implementation of pro-  
15      grams, under this Act and other Federal Acts,  
16      for the benefit of such individuals;

17           “(C) support, conduct, and arrange for research  
18      in the field of LGBT aging with a special emphasis  
19      on gathering statistics on older LGBT individuals;

20           “(D) collect and disseminate information re-  
21      lated to challenges experienced by older LGBT indi-  
22      viduals with an emphasis on the challenges experi-  
23      enced by older LGBT individuals residing in rural  
24      areas and older LGBT individuals living with human

1 immunodeficiency virus and acquired immune defi-  
2 ciency syndrome (HIV/AIDS);

3 “(E) recommend policies and priorities bene-  
4 ficial to older LGBT individuals and promote the  
5 implementation and adoption of culturally competent  
6 care and services for such individuals; and

7 “(F) administer and evaluate grants that will  
8 help older LGBT individuals, including grants under  
9 section 423.

10 “(4) Not later than January 31 of fiscal year 2023  
11 and of each fifth fiscal year thereafter, the Director shall  
12 submit to Congress a report describing the activities car-  
13 ried out under this subsection during the preceding 5 fis-  
14 cal years.”.

15 **SEC. 4. RURAL OUTREACH GRANT PROGRAM.**

16 Part A of title IV of the Older Americans Act of 1965  
17 (42 U.S.C. 3032 et seq.) is amended by adding at the end  
18 the following:

19 **“SEC. 423. RURAL OUTREACH GRANT PROGRAM.**

20 “(a) DEFINITIONS.—In this section:

21 “(1) DIRECTOR.—The term ‘Director’ means  
22 the Director of the Office of Older LGBT Policy, es-  
23 tablished under section 201(g).

24 “(2) ELIGIBLE ENTITY.—The term ‘eligible en-  
25 tity’—

1               “(A) means an entity that submits an ap-  
2               plication to the Director in accordance with  
3               subsection (d), and is—

4               “(i) a State; or  
5               “(ii) an agency, organization, or insti-  
6               tution that focuses on serving the needs of  
7               older individuals or LGBT individuals; and  
8               “(B) may include an area agency on aging  
9               for a rural area or a multipurpose senior cen-  
10              ter.

11              “(3) RURAL AREA.—The term ‘rural area’  
12              means an area that is not designated by the United  
13              States Census Bureau as an urbanized area or  
14              urban cluster.

15              “(b) PURPOSE.—The purpose of this section is to  
16              provide eligible entities with resources and incentives to  
17              devise a long-term comprehensive strategy for connecting  
18              with older LGBT individuals residing in rural areas and  
19              meeting the needs of such individuals.

20              “(c) AUTHORITY FOR GRANTS.—The Director may,  
21              for the purpose described in subsection (b), make grants  
22              to eligible entities to carry out activities approved by the  
23              Director in accordance with subsection (e).

24              “(d) APPLICATIONS.—

1           “(1) IN GENERAL.—An eligible entity seeking a  
2 grant under this section shall submit an application  
3 to the Director at such time, in such manner, and  
4 containing such information as the Director may  
5 reasonably require, including the contents described  
6 in paragraph (2).

7           “(2) CONTENTS.—An application for a grant  
8 under this section shall contain—

9                 “(A) a description of the proposed activi-  
10 ties to be supported by the grant;

11                 “(B) a description of the size and charac-  
12 teristics of the population in a rural area served  
13 by such activities;

14                 “(C) a description of the public and private  
15 resources expected to be made available in con-  
16 nection with such activities;

17                 “(D) a demonstrated intent to partner  
18 with local organizations in rural areas in car-  
19 rying out such activities;

20                 “(E) evidence in a form acceptable to the  
21 Director that such activities will meet urgent  
22 needs that are not met by available public and  
23 private sources; and

24                 “(F) such other information or certifi-  
25 cations that the Director determines necessary

1           to achieve the purpose described in subsection  
2           (b).

3         “(e) APPROVED ACTIVITIES.—

4         “(1) IN GENERAL.—A grant under this section  
5         shall be available only for activities approved by the  
6         Director to carry out a strategy designed to create  
7         a cooperative and lasting partnership between older  
8         LGBT individuals residing in rural areas and the el-  
9         igible entity receiving the grant.

10        “(2) APPROVED ACTIVITIES.—Activities ap-  
11        proved by the Director may include initiatives that—

12           “(A) engage in education and training  
13           around community outreach to older LGBT in-  
14           dividuals residing in rural areas;

15           “(B) reduce isolation and improve access  
16           to care for older LGBT individuals residing in  
17           rural areas by building relationships between  
18           such individuals and the local community;

19           “(C) foster relationships between local  
20           LGBT-affirming service providers and older  
21           LGBT individuals residing in rural areas;

22           “(D) improve LGBT cultural competency  
23           among organizations and personnel providing  
24           services to older individuals residing in rural  
25           areas; and

1                 “(E) expand the use of non-discrimination  
2                 policies that—

3                         “(i) protect sexual orientation and  
4                         gender identity; and

5                         “(ii) create community spaces that are  
6                         inclusive to older LGBT individuals.

7                 “(f) STANDARDS AND GUIDELINES.—The Director  
8     shall establish standards and guidelines for approved ac-  
9     tivities supported by a grant under this section. Such  
10    standards and guidelines shall permit an eligible entity re-  
11    ceiving such a grant to refine or adapt the standards and  
12    guidelines for an individual project, where such a refine-  
13    ment or adaptation is made necessary by a local cir-  
14    cumstance.

15                 “(g) COORDINATION WITH LOCAL ENTITIES.—

16                 “(1) COOPERATION.—An eligible entity receiv-  
17     ing a grant under this section shall, in carrying out  
18     the approved activities supported by the grant, agree  
19     to cooperate and coordinate with—

20                         “(A) the agencies of the relevant State and  
21                         local governments responsible for providing  
22                         services to older LGBT individuals in the area  
23                         served by such activities; and

1               “(B) other public and private organizations  
2               and agencies providing services for older LGBT  
3               individuals in such area.

4               “(2) PRIORITIZATION.—An eligible entity re-  
5               ceiving a grant under this section shall prioritize co-  
6               operating and coordinating with public and private  
7               organizations and agencies that primarily serve eco-  
8               nomically underserved populations, as determined by  
9               the Director.

10              “(h) REPORTS.—Not later than January 31 of fiscal  
11             year 2020, and of each second fiscal year thereafter, the  
12             Director shall submit to Congress a report describing the  
13             activities carried out under this section during the pre-  
14             ceding 2 fiscal years.”.
