HOW IDAHO BENEFITS

The Inflation Reduction Act will reduce health care and prescription drug costs for Idaho seniors, people with disabilities and families.

Making Approved Vaccines Free Starting in 2023



Ensures approved vaccines under Medicare Part D are free, helping over 24,000 Idahoans.¹

Lowering Insulin Copays Starting in 2023



Reduces Medicare copays to a maximum of \$35 per month, lowering insulin costs for 8,600 Idahoans.²

Reducing Health Care Premiums Starting in 2023



Lowers Marketplace premiums for roughly 54,000 Idahoans by hundreds of dollars per person, on average, in 2023.³

Helping Low-Income Americans Starting in 2024



Increases financial assistance to over 2,000 low-income Idahoans to help them afford their prescription medications.⁴

Capping Out-of-Pocket Costs Starting in 2025



Caps prescription drug costs at \$2,000 a year for nearly 265,400 Idahoans with Medicare Part D – giving the more than 8,000 Idahoans who will exceed this limit the help they need.⁵

Lowering Prescription Drug Prices Through Negotiation

Starting in 2026



Beginning in 2026, Medicare-negotiated prescription drug prices will go into effect, reducing costs for certain high-cost drugs and out-of-pocket costs for seniors and people with disabilities.⁷
