Capping Out-of-Pocket Costs

Starting in 2025

Caps prescription drug costs at \$2,000 a year for over 522,000 lowans with Medicare Part D⁵– giving nearly 21,900 lowans who will exceed this limit the help they need.⁶



Lowering Prescription Drug Prices Through Negotiation Starting in 2026

Beginning in 2026, Medicare-negotiated prescription drug prices will go into effect, reducing costs for certain high-cost drugs and out-of-pocket costs for seniors and people with disabilities.
