Making Approved Vaccines Free Starting in 2023 Ensures approved vaccines under

Medicare Part D are free, helping nearly 46,000 Kentuckians.¹



Lowering Insulin Copays Starting in 2023

Reduces Medicare copays to a maximum of \$35 per month, lowering insulin costs for over 29,200 Kentuckians.²



Reducing Health Care Premiums Starting in 2023 Lowers Marketplace premiums for roughly 63,000 Kentuckians by hundreds of dollars per person, on average, in 2023.³

Helping Low-Income Americans Starting in 2024

Increases financial assistance to nearly 10,300 low-income Kentuckians to help them afford their prescription medications.⁴



Capping Out-of-Pocket Costs Starting in 2025

Caps prescription drug costs at \$2,000 a year for nearly 750,500 Kentuckians with Medicare Part D⁵– giving the nearly 21,700 Kentuckians

who will exceed this limit the help they need.



Beginning in 2026, Medicare-negotiated prescription drug prices will go into effect, reducing costs for certain high-cost drugs and out-of-pocket costs for seniors and people with disabilities.⁷
