Capping Out-of-Pocket Costs

Starting in 2025

Caps prescription drug costs at \$2,000 a year for nearly 271,300 Nebraskans with Medicare Part D - giving the nearly 13,400 Nebraskans who will exceed this limit the help they need. 6



Lowering Prescription Drug Prices Through Negotiation Starting in 2026

Beginning in 2026, Medicare-negotiated prescription drug prices will go into effect, reducing costs for certain high-cost drugs and out-of-pocket costs for seniors and people with disabilities.
