Reduces Medicare copays to a maximum of \$35 per month, lowering insulin costs for over 21,700 Oklahomans.²

Reducing Health Care Premiums Starting in 2023

Lowers Marketplace premiums for roughly 182,000 Oklahomans by hundreds of dollars per person, on average, in 2023.³



Helping Low-Income Americans Starting in 2024

Increases financial assistance to 6,100 low-income Oklahomans to help them afford their prescription medications.⁴



Capping Out-of-Pocket Costs

Starting in 2025

Caps prescription drug costs at \$2,000 a year for nearly 533,600 Oklahomans with Medicare Part D⁵– giving the more than 21,000 Oklahomans who will exceed this limit the help they need.⁶



Lowering Prescription Drug Prices Through Negotiation Starting in 2026

Beginning in 2026, Medicare-negotiated prescription drug prices will go into effect, reducing costs for certain high-cost drugs and out-of-pocket costs for seniors and people with disabilities.⁷
