Making Approved Vaccines Free Starting in 2023



Ensures approved vaccines under Medicare Part D are free, helping over 17,500 South Dakotans.¹



Lowering Insulin Copays Starting in 2023

Reduces Medicare copays to a maximum of \$35 per month, lowering insulin costs for nearly 4,800 South Dakotans.²



Reducing Health Care Premiums Starting in 2023

Lowers Marketplace premiums for roughly 40,000 South Dakotans by hundreds of dollars per person, on average, in 2023.³



Helping Low-Income Americans Starting in 2024

Increases financial assistance to nearly 900 low-income South Dakotans to help them afford their prescription medications.⁴



Capping Out-of-Pocket Costs

Starting in 2025

Caps prescription drug costs at \$2,000 a year for nearly 128,700 South Dakotans with Medicare Part D⁵– giving the more than 6,100 South Dakotans who will exceed this limit the help they need.⁶



Lowering Prescription Drug Prices through Negotiation Starting in 2026

Beginning in 2026, Medicare-negotiated prescription drug prices will go into effect, reducing costs for certain high-cost drugs and out-of-pocket costs for seniors and people with disabilities.
