TRUMP BUDGET ELIMINATES KEY MEDICARE ASSISTANCE PROGRAM

Ensuring Seniors Access to Free and Unbiased Medicare Counseling is Critical

The State Health Insurance Assistance Program (SHIP) supports Medicare beneficiaries, their families and caregivers, by providing information, counseling, and assistance with enrollment in Medicare. Approximately 55 million seniors and persons with disabilities are enrolled in Medicare, and SHIP provides assistance, free of charge, to help navigate the complex Medicare system. In 2016 alone, over 14,000 SHIP counselors connected with more than 6.2 million individuals.2

How SHIP Works

Funded through the federal U.S. Department of Health and Human Services, SHIP counselors are located in all 50 states and four U.S. territories. These counselors provide personalized one-on-one counseling in person, by phone, online, or via email. SHIPs also organize community education events and widely disseminate information on Medicare coverage and benefits. SHIP counselors are trained and certified to help individuals, families, and caregivers make informed health care decisions.

How SHIP Benefits Seniors

SHIP counselors are a critical resource to Medicare beneficiaries, empowering individuals to make well informed health care decisions that fit their needs and budget. Trained counselors help individuals navigate Medicare enrollment, compare Medicare Supplemental (Medigap) policies, provide information on how long term care insurance works in conjunction with Medicare, and refer beneficiaries to other agencies like the Social Security Administration and Medicaid where appropriate. A major focus of SHIP education has been enrollment in prescription drug coverage and programs that help beneficiaries with limited income pay for their health care such as the Medicare prescription drug low-income subsidy (LIS) program and the Medicare Savings Program (MSP).3 These efforts help to ensure that the most needy and at-risk beneficiaries have the support to navigate the growing complexities of the Medicare system.

SHIP in Action

Mary, an 85-year old grandmother from Southwest Pennsylvania, was paying \$600 every two months for a Medigap policy and struggling with everyday expenses. Concerned, Mary's granddaughter contacted a local SHIP counselor to discuss options. The SHIP counselor helped Mary understand her coverage and determined that because she was covered by both Medicare and Medicaid, Mary didn't need a Medigap policy. Mary now saves her \$600 because of the help of a SHIP counselor.

The Trump Budget Threatens SHIP Resources

The FY2018 budget proposed by the Trump Administration puts funding for the SHIP program at risk, threatening to eliminate more than \$52 million in discretionary funding for SHIP activities. Eliminating the program means Pennsylvania would lose \$2 million in funding for the APPRISE program, the name of the SHIP program in Pennsylvania. Without funding, thousands of Pennsylvanians would lose the access to SHIP services. The number of Medicare beneficiaries is growing and SHIP counselors provide essential support.4 A loss of funding for SHIP programs would hurt Pennsylvanians and leave millions without access to free and impartial Medicare counseling.
